



Purpose of This Document

Risk Assessment

- To ensure any dangers present in any premises used by any section or sections of the scout group are identified and kept to an acceptable level
- To ensure any risks associated with camps / trips and activities are identified and kept to an acceptable level
- To ensure any leaders or adults involved with the running of the sections on a regular basis are vetted in accordance with Scout Association rules.

The purpose of this document is to ensure most if not all major risks of injury associated with the smooth running of the scout group are identified and control measures are put in place to reduce the risk of injury to an acceptably low level.

This risk assessment should be reviewed on a regular basis several times a year, or immediately following any incident or near miss situation so that any lessons which could be learned are acted upon as soon as practicable and the risk assessment updated accordingly

Location of building services

Electricity

The main fuse board and mains inlet switch is to be identified by the section leader prior to commencement of any session. If the section leader or their assistant has any concerns over the location, use or safety of the electrical switchboard they must contact the premises keyholder immediately

Water

The main inlet stop cock is normally located under the kitchen sink in premises. If the premises are unfamiliar the section leader should familiarise themselves with the location of the stop cock.

In some infrequently used premises it may be necessary to turn the water supply off during colder weather and this is to be confirmed by the keyholder.

Gas

The main gas supply and controls are to be identified by the section leader prior to commencement of any session. If the section leader or their assistant has any concerns over the location, use or safety of the gas supply they must contact the premises keyholder immediately. If any gas leak is suspected the gas must be turned off, building evacuated and leak reported immediately to relevant gas board.

Location of Emergency Equipment

Fire Escapes

All fire escapes are to be identified and regular fire drills carried out by all sections using the premises. Fire escape routes are to be kept clear of obstructions and all final entry points are to be clearly identified and kept unlocked. A roll call is to be taken following all evacuations.

First Aid

The first aid box, Eye wash station and accident book are normally located in the kitchen. All leaders should also have full first aid kits and accident books with them for each session.

Fire Blanket

This is usually located next to the cooker in the kitchen

Fire Extinguishers

Location of fire extinguishers to be familiar to section leaders and members present. Only small fires should be tackled with equipment provided and premises should be evacuated immediately and fire brigade called. Any suspected faulty or empty extinguishers should be reported immediately to the keyholders.

Smoke Detectors

Leaders to check location and workings to all installed detectors. Any problems to be reported immediately to the premises keyholders.

Emergency Procedures

Flooding / Water leak

Turn off water at main stop cock and contact keyholder with details of the problem

If leak or burst pipe is before stop cock, locate stopcock in field and turn water off there, then contact keyholder with details of the problem

Smoke alarm activation

- Leaders to ensure everyone is evacuated as quickly as possible using the nearest available fire exit while the cause if the smoke alarm activation is investigated.
- 2. The assembly point is normally the car park outside the building
- 3. Head count to be performed to ensure all persons are accounted for
- 4. If no immediately cause for the activation is seen 2 leaders should check the area thoroughly
- 5. If a fire is found immediately proceed with **FIRE** procedure below
- 6. If no cause is found Andy Jones to be informed with details of which smoke alarm activated so a record can be kept

Fire

- 1. **Shout Fire** to make everyone aware of the situation
- 2. Leaders to ensure everyone is evacuated as quickly as possible using the nearest available fire exit.
- 3. Fire should only be tackled with fire fighting equipment if very small or to enable the evacuation of the building
- 4. The assembly point is the car park at the front of the building
- 5. Head count to be performed to ensure all persons are accounted for
- 6. Fire Brigade should be called and informed of the location of the hut
- 7. The building should not be re-entered until declared safe by the fire brigade

Materials Storage

Flammable Materials

GAS

<u>All</u> gas cylinders are to be stored in locked metal storage facility outside the premises to prevent the risk of explosion due to build up of gases in a confined space

Flammable Liquids

<u>All</u> Flammable liquids are to be stored in clearly marked containers of the correct type in the locked metal storage facility outside the premises to prevent the risk of explosion due to build up of flammable vapours in a confined space

Flammable Material storage Facility

This is a locked metal cupboard with sufficient added ventilation low down to prevent the build up of flammable gases or vapours from the materials stored inside.

As the cupboard is an enclosed structure it should have the relevant standard HAZCHEM warnings on the outside to alert the emergency services to its contents and reduce any risks of explosion or injury to emergency service personnel or general public (residents of neighbouring houses) in the event of an emergency incident.
